### FTW-Refresh Fort Worth Furniture Project

#### Overview

The U.S. Probation and Pretrial Services Office, Northern District of Texas (TXNP) seeks to purchase furniture for the Fort Worth office located at Eldon B. Mahon Federal Building, 501 W. 10th Street., Suite 406, Fort Worth, TX 76102-3639.

The acquisition will include redesigning the existing pentagon room with conference tables and chairs, adding and replacing furniture in offices with new furniture, including a desk, wardrobe, and pedestal. In addition some offices will

need to add printer tables.

#### Proposal Requirements

Companies wishing to bid on this project are required to attend an on-site pre-bid meeting to be held on August 06, 2024, at 10:00 AM to walk through all spaces.

Proposals must include:

- A design of the open pentagon room and kitchen costs for design services (if applicable)
- An itemized breakdown of furniture costs including quantities for both areas
- Removal of existing furniture
- Any other associated costs (i.e., travel expenses)
- Estimated timeline for deliverables
